Sub: Revision of pension /family pension in terms of the recommendation of 6th CPC

Revision of pension /family pension of pre 1-1-2006 Pensioners/family pensioners is being implemented in terms of Govt. of India OM No F.No 38/37/08-P&PW(A) dated 1-9-2008 and No 38/37/08-P&PW(A) Pt 1 dated 14-10-2008. In order to ascertain the applicability of benefits (if any) under para 4.2 of the OM dated 1-9-2008 referred to above which lays down that the fixation of pension will be subject to the provision that the revised pension wef 1-1-2006 in no case shall be lower than the 50% of the minimum of the Pay in the pay band plus the Grade pay corresponding to the pre-revised pay scale from which the pensioner has retired.

Similarly, the Family pension wef 1-1-2006 shall not be less than 30% of the minimum of the Pay band and applicable grade pay corresponding to the pay scale last held by the pensioner/deceased Govt. servant.

In order to facilitate the above all the department of Telecommunication pensioners/family pensioners who have retired from J&K circle are requested to submit the information given in the enclosed proforma with supporting documents to the Units from which they retired with copies thereof to this office.

1. All pensioners are advised to submit the above information to the Head of the Deptt/ office from where the Govt. employee retired.
2. Attested photocopy of any one of the following documents in support of date of birth of the spouse / eligible family member be submitted .
 - i Pan card
 - ii. Matriculation Certificate (containing the information regarding date of birth)
 - iii. Passport, (iv) CGHS Card (v) Driving Licence (if it containing date of birth)
 - vi. Vote's ID card may also be accepted as proof of date of Birth subject to the condition that the pensioner /family pensioner certifies that he is not a matriculate and that he/she does not have any of the documents mentioned from i to v above.
 - vii. In case pensioner / family pensioner is unable to submit any of the documents mentioned above (i) to (Vi) but claims additional pension based on some other documentary evidence such case will be submitted to the administrative ministry whose decision in this regard will be final (DP&PW order No. 38/37/08-P&PW (A) dated:-21/05/2009,11.08.2009&28.09.2010 may be referred to).
3. The above information will help to expedite the cases. In the absence of the above information /Application, the process of revision of pension/family pension may be delayed and the case revised as per the record available with Head of Deptt/Head of office.
4. In case their document have already been provided to the Bank from where pension is being disbursed, mention may be made of the fact.
